## CONDITIONS OF PARTICIPATION

JZK, Inc. is pleased to have you participate in Ramtha's School of Enlightenment (hereafter the "School") so long as you agree to abide by these Conditions of Participation. These Conditions apply to students, teachers, and other participants in the School, and apply to all future School events or activities, whether accessed in person at a live event or electronically. JZK, Inc. has the right to refuse any person admission or enrollment, except as may be prohibited by law. These Conditions shall remain in full force and effect even if your permission to participate is revoked. As a condition to your participation you must agree to the following:

1. The information and techniques taught or distributed by the School are for your knowledge only. You are licensed to use this information and techniques for your personal use only. By signing these Conditions of Participation, you agree not to teach or otherwise disseminate through speeches, books, articles, media interviews, classes, presentations, social media, email, text, tweet, or other forms of mass or group distribution (hereafter "Teach or Disseminate") any information or techniques that you learn at the School or that are taught by the School — whether or not you receive them directly from the School — without the prior written consent of the School. 2. The materials provided by the School are protected by U.S., Washington State, and international trademark and copyright laws. You are prohibited from making your own recordings of events. You are not authorized to and agree not to copy, reproduce, prepare adaptations, publicly distribute, publicly perform, or publicly display any of those materials — whether or not you receive them directly from the School — without the prior written consent of the School. All events are routinely recorded on audiotapes and archived under the registered trademark RAMTHA DIALOGUES® which serves as the official record of the teachings of Ramtha. Portions of the official record have also been reproduced in various media with the express permission of JZ Knight. By signing these Conditions of Participation, you agree that you will not attribute to Ramtha any statement that is not part of the official record. 3. Ramtha employs interactive methods of teaching, some of which may carry a risk of injury to participants. While the School strives to provide a safe environment, students assume the risk of injury involved with Fieldwork®, the Tank®, and any other activity at the School. To induce the School to allow you to participate in these and any activity at the School, you represent that you are physically capable of doing so. Participation in these activities is encouraged but not required. If you do participate, you agree to exercise reasonable caution and prudence. Participation involves interaction with others.
