## NONDISCLOSURE AGREEMENT

In exchange for admission to any events by JZK, Inc., DBA Ramtha's School of Enlightenment or RSE (hereafter "JZK"), I agree to be bound by all of the following terms and conditions. This Nondisclosure Agreement (hereafter "Agreement") applies to all JZK events or activities, whether accessed in person at a venue or electronically. I understand one of the central purposes of this Agreement is to protect the confidentiality and integrity of JZK's information and techniques. I understand and agree that this Agreement shall remain in full force and effect even if my permission to participate is revoked. Specifically, I agree to the following:

1. I acknowledge and agree that the information and techniques either taught or disseminated by JZK, whether previously or currently taught, and regardless of the form or medium presented (hereafter "Protected Information") is for my personal knowledge only. I agree that I am permitted to use the Protected Information for my personal use only and that I am expressly prohibited from using or disclosing the Protected Information for any other purpose. All Protected Information remains the property of JZK. **I agree not to teach or otherwise disseminate through speeches, books, articles, media interviews, classes, presentations, social media, email, text, tweet, or other forms of mass or group distribution** (hereafter "Teach or Disseminate") any Protected Information that is taught by JZK — whether or not I receive the Protected Information directly from JZK — without the prior written consent of JZK. I also agree not to assist or facilitate other persons in Teaching or Disseminating any Protected Information without the prior written consent of JZK.

2. I acknowledge that I am agreeing to the terms and conditions herein as a student and participant, and not as an employee or independent contractor. I also acknowledge and agree that this Agreement does not restrain or prohibit me from engaging in a lawful profession, trade, or business of any kind.

3. I understand and agree that this Agreement also applies to information that is protected under applicable trademark and copyright laws. I understand and agree that I am prohibited from making recordings of events. I understand that JZK routinely records all events. I understand that portions of the recordings have been reproduced in various media with the express permission of JZ Knight. Materials published by or with the permission of JZK, Inc. or JZ Knight do not operate as a waiver to any of the terms of this Agreement. I understand and agree that I am not authorized to copy, reproduce, prepare adaptations, publicly distribute, publicly perform, or publicly display any JZK materials — whether or not I receive them directly from JZK — without the prior written consent of JZK. I also agree that I will not attribute to Ramtha any statement that is not part of JZK's official record.

4. I understand that JZK employs interactive methods of teaching, some of which may carry a risk of injury to participants, that participation is encouraged but not required. If I do participate, I agree to exercise reasonable caution and prudence. For all activities at JZK events, I hereby release JZK, its employees, and agents of all liability for damages, illness, and injuries I incur, except for JZK's gross negligence.

5. Event-participants are regularly photographed and videotaped by JZK. These images may be used by JZK in literature, videos, press releases, internet postings, or other promotions. I authorize any recorded image of me at JZK events to be used at a later time without notice to or additional consent by me and without any compensation.

6. I agree that this Agreement may be enforced by equitable remedies, including immediate injunctive relief, without JZK posting a bond or other security. Further, I agree that because actual damages from a breach may be difficult to ascertain, all income I receive directly or indirectly from activities in violation of this Agreement as determined by a court of competent jurisdiction will be paid to JZK as compensation for the damages that JZK incurs because of such breach. I agree to pay on demand the reasonable attorneys' fees and costs incurred by JZK in connection with the enforcement of this Agreement, including those incurred on appeal.

JZK makes no representations, assurances, or warranties of any kind, express or implied, including any warranties or representations as to results, which depend on numerous factors beyond JZK's control. In addition, JZK SPECIFICALLY DISCLAIMS ANY WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

8. This Agreement will remain in effect and enforceable for the duration of my life. Any consent referenced in this Agreement may be withheld at JZK's sole and absolute discretion. This Agreement constitutes the entire Agreement between the parties pertaining to the subject matter hereof and supersedes any and all prior agreements of the parties, whether oral or written, relating to the subject matter hereof. This Agreement operates retroactively to the date of my first participation in any event by JZK. No modification or amendment of this Agreement, or any waiver of any right, power, or privilege under this Agreement, will be binding upon any party unless set forth in writing. If any provision of this Agreement is found by a court of competent jurisdiction to be invalid, unlawful, or unenforceable to any extent, then the remaining provisions will continue in effect to the greatest extent permitted by law. No party may assign or transfer any of its rights or obligations under this Agreement without the prior written consent of the other party. This Agreement will be governed by and construed according to the laws of the State of Washington without regard to conflicts of law principles. I agree that this Agreement is not to be construed in favor of either party.
